Finding Stability and Hope

at Good Shepherd

We walk with young mothers on the journey from crisis to stability. One of our current maternity shelter residents is a 19-year-old client who just gave birth to her first baby in September.



Before arriving at Good Shepherd, she had nowhere stable to turn. She was often couch hopping and eventually found temporary refuge at her cousin's home. That cousin, a former Good Shepherd client herself, encouraged her to reach out to our ministry for help.

This young woman came to us with a history of homelessness, gaps in her education, and the pain of past domestic violence. With the support of Good Shepherd staff, she is now enrolled in a GED program and has already completed two tests. Staff describe her as receptive, pleasant, and hardworking. She knows every staff member by name and has embraced the supportive community around her.

Her story is still unfolding, but it is already one of resilience, hope, and healing. By offering shelter, education support, and care, Good Shepherd is helping her prepare for motherhood with confidence and the chance at a brighter future.

Our work does not end at placement. In partnership with Lutheran Family and Children Services, we now offer monthly support groups for birth mothers—both virtual and in person. These gatherings provide a caring space to connect with other women who have made the courageous choice of adoption, guided by adoption professionals. Support for birth mothers is lifelong, not just at the moment of placement.

This summer, Good Shepherd also hosted its first annual adoptive family picnic. Families came together to celebrate the beautiful gift of adoption, enjoy time with one another, and share in the joy of their journeys. The day was filled with laughter, smiles, and new friendships.

Pregnancy and Parenting SupportWalking Beside Young Mothers

Our Pregnancy and Parenting Support (PPS) program walks beside young mothers as they build stable, hopeful futures for themselves and their children.

One of our clients, an 18-year-old mother, grew up facing emotional and physical abuse and spent two years living on the streets. Even in the face of these hardships, she was determined to finish school and proudly graduated from high school last year.

When she became pregnant, she enrolled in Good Shepherd's PPS program. Here, she found the emotional support, guidance, and parenting lessons she needed to take her next steps. With the help of her PPS worker, she secured her own apartment, began working part time, and became a certified phlebotomist. She even completed driving lessons, passed her test, and bought her first car.

Her story is a powerful example of how dedicated support can transform lives. By walking with young mothers like her, PPS helps ensure that every child has the opportunity to grow up in a safe, loving, and hopeful home.
